Please find below Circular regarding Planning, Implementation and Monitoring of New Infrastructure Projects for PM Gati Sakti:-



PM Gati Shakti is a transformative approach of integrated and holistic planning of projects that was launched by the Hon'ble Prime Minister. It aims to improve multimodal connectivity, logistics efficiency and address critical gap for seamless movement of goods and services, with focus on minimizing disruptions and ensuring timely completion of works.

2. Under this approach a GIS based technology platform – PM Gati Shakti National Master Plan Portal has been developed. It is a comprehensive map providing a bird's eye view of infrastructure development with key layers of various Economic Zones, Infrastructure & Utilities across the country. The Gati Shakti Master Plan Portal provides entire data at one place with GIS Based spatial planning and analytical tools. It is designed to enhance efficiency and have integrated approach by use of latest satellite imagery for visual understanding, co-ordination among all the stakeholders, synchronization in implementation of projects, planning tools for route planning, land acquisition, permissions and congestion reduction and dashboard based periodic monitoring for progress.

3. PM Gati Shakti Portal provides a common umbrella platform through which infrastructure projects can be planned in an efficacious manner. PM Gati Shakti Portal will give a new direction to the development of modern infrastructure through planning, implementation and monitoring; besides cutting down on time and cost overruns of project.

4. In the context of the above, all new infrastructure projects to be carried out in this Union Territory shall strictly follow the following criteria prior to obtaining any Administrative approval/expenditure sanction therefor:

I. All new infrastructure Projects should be planned, implemented and monitored in PM Gati Shakti Portal.

- II. The SOP for data management on PM Gati Shakti National Master Plan Platform issued by the Department for Promotion of Industry and Internal Trade (Logistics Division), Ministry of Commerce & Industry, Government of India should be strictly adhered to during effective planning and creation of required GIS layers for any specific projects.
- III. All departments shall examine and certify that effective planning and creation of required GIS layers for any specific project has been made by the concerned Departments / Autonomous bodies / Agencies. The Certificate shall be obtained prior to submission of proposal to Competent Authority seeking administrative approval/expenditure sanction for any new infrastructure projects.
- IV. A Check List in the enclosed proforma shall be invariably accompanied with the proposal while seeking concurrence of Finance Department for the issue of administrative approval / expenditure sanction for any new infrastructure projects.
