**NOTIFICATION**

In exercise of the powers conferred under Section 40 of Dadra and Nagar Haveli Panchayat Regulation 2012, the Administrator, Dadra and Nagar Haveli is pleased to make the following rules namely :-

1. Subject to the rules made under this regulation a Gram Panchayat in relation to the services provided by It directly, may levy:
  - (a) a Tax on the owners or occupiers of building;
  - (b) a tax on trades. callings and employment;
  - (c) a tax on vehicles other than mechanically propelled vehicles kept within the limits of the Gram Panchayat;

- (d) a tax on sale of cattle within the limits of the Gram Panchayat;
- (e) a theatre or show tax on entertainments and amusements;
- (f) a lighting tax.
- (g) a drainage tax
- (h) fees for providing sanitary arrangements at such places of worship of pdgrimage, fairs and meals with in jurisdictions;
- (i) fees for sale of goods in markets, melas, fairs and festivals,
- (j) fee for grazing of cattle in grazing lands under the management of the Gram Panchayat:
- (k) fee for providing the watch and ward of crops in the Gram Panchayat;
- (l) license fee for playing of public ferry:

1. Any other taxes approved by the Administrator

**SCHEDULE FOR RATE OF TAX ON BUILDINGS**

Sr. No.	Rate of Tax based on Capital Value	Minimum	Maximum
(a)	For all buildings except those in (b) and (c) below	₹ 15 paise per ₹ 100/- of the Capital value or fraction thereof.	₹ 30 paise per ₹ 100/- of the Capital value or fraction thereof.
(b)	Building exclusively used for any commercial purposes	₹ 30 paise per ₹ 100/- of the Capital value or traction thereof.	₹ 60 paise per ₹ 100/- of the Capital value or traction thereof.
(c)	Building exclusively used for any industrial purpose / factory building / shed.	₹ 45 paise per ₹ 100/- of the Capital value or traction thereof.	₹ 90 paise per ₹ 100/- of the Capital value or traction thereof.
(d)	Rate of tax based on annual letting value	5% of the annual letting value.	8% of the annual letting Value

This shall come into force with immediate effect.
