Following Exemptions shall be considered for the bellow mentioned types and the above rates shall not apply:

- 1. All buildings and lands used for religious purpose are exempted from property tax.
- 2. Retired Soldiers and their widow/widower are exempted from Property Tax of building and land on which they are living.
- 3. For Property tax for an area less than or equal to 25 square meters Rs. 250/ per annum has been fixed as property tax per annum.
- 4. Tax for Houses allotted to beneficiaries under various schemes of poverty Alleviation program is fixed as Rs. 250 / per annum.
- 5. Tax for kutcha house, old house, and traditional huts built with indigenous material having ineligible rent value and occupied by poor household is fixed as Rs. 250 / per annum.
