



Changes in accordance to the modified Act were also carried out in the Dadra & Nagar Haveli and Daman & Diu Excise Duty Rules, 2020. 



It is certified that the Dadra and Nagar Haveli and Daman and Diu (Extension with modifications of the Goa, Daman and Diu Excise Duty Act, 1964) Excise Regulation, 2020 was promulgated by the Hon'ble President of India on 24th January 2020, by virtue of which the Goa, Daman and Diu Excise Duty Act, 1964 with modifications as provided in the Regulation, was extended to the merged UT of Dadra & Nagar Haveli and Daman & Diu. The said Regulation retained all the penal provisions of the erstwhile Goa, Daman and Diu Excise Duty Act, 1964 in the modified Act. Dadra & Nagar Haveli and Daman & Diu is a Union Territory without a legislature, therefore, any amendments to the said Act made by the Parliament or through the promulgation of Regulation is fully implemented in the Union Territory.

Further, in exercise of powers conferred the DNH & DD Excise Duty Act, 1964, the UT Administration framed the DNH & DD Excise Duty Rules, 2020, which again retained the minor fine/penalty provisions of the erstwhile Goa, Daman & Diu Excise Duty Rules, 1964.

Provision for imposing fines and to compound offence exists in the Dadra & Nagar Haveli and Daman & Diu Excise Duty Act, 1964. No monetary penalties are levied for missing documents. Minor penalties are imposed for late submission of renewal applications and for minor errors. Proportional penalties and graded punishment system is practiced by the competent authority depending on the gravity and severity of offences. Appellate mechanism has been established in the said Act for fair and timely resolution of grievances. The compliances related to the Dadra & Nagar Haveli and Daman & Diu Excise Duty Act, 1964 with respect to decriminalization have been uploaded on RC Portal.
